BOWLING GREEN TOWNSHIP BOARD OF TRUSTEES

Held: March 30, 2010

Bowling Green Township Board of trustees opened this regular meeting at 7pm with roll call. All trustees and Fiscal Officer are present.

VISITORS: Naomi Compton, Tom Robb, Tim, John Findley, Dee Krier, Evelyn VanBuren, Barb Selegue, Ronald Duval, Patty Volland, Adrian Smith, Mark Burgeww, David Skinner, David VanBuren, Michael Pitcher, Yetta Paeltz.

GUEST SPEAKER Licking County Commission Candidate Naomi Compton introduced herself and spoke for a few minutes.

CORRESPONDANCE Larry Lloyd has bags and gloves available for the litter cleanup. Trustee Watkins said there is a group of boy scouts that plan to clean Honda Hills and someone will be cleaning up Somerset Road as community service.

FO received notice from zoning commission chair Barb Wade of her resignation.

Trustee Watkins received a call from a resident in Dogwood about some sod that needs repaired after snow plowing. They have repaired the sod

Letter from Mr. Kern about lot size in ag district. Trustee Watkins said the board has begun the process to change the lot size. He also talked to the Planning commission and they feel that 2 acres would be a good lot size.

Letter from Mr. Kern about a couple of alleys in Brownsville which aren't listed as they should be. Trustee Watkins talked to the county engineer about the alleys and he said to leave them on the road list as they are.

REPORTS

Comprehensive Plan Committee Michael Pitcher reported the committee has the survey complete and are ready to make copies and send it out. The planning commission will be helping with the printing and with the use of the county's postage machine. The Comp. committee would like to send out the survey to every registered household and also include a self address, postage paid envelope for the resident to return the survey to the Planning committee. The postage will cost \$875.96. Trustee Watkins made a motion for the Comprehensive Plan Committee to mail out surveys to every household and appropriate the cost for postage of \$900. Seconded by Trustee VanBuren. All in favor. Trustees would also like the information to be sent to the Advocate.

PARK COMMITTEE Vickie Fogarty reported the park committee plans to have their annual Easter Egg hunt and bake sale. They are also making plans for the National Rd Yard Sale during Memorial day weekend, a hog roast for labor day and a Halloween Party. They have also discussed applying for more grants.

UNFINISHED BUSINESS Trustees discussed the resolution regulating transient vendors. The board decided to require vendors to register with the fiscal officer, there will be no fee, and the registration will be valid for 90 days. FO read full resolution into the record. Trustee VanBuren made a motion to accept the resolution. Trustee Hupp Seconded the motion. All in favor. Full resolution on file with the FO.

Trustee Hupp talked to the County Auditor's office about the old post office building. The Auditor's office will begin the foreclosure process and notify the property owner.

Trustees discussed the open zoning commission chair position. Trustee Watkins made a motion for Tom Robb to finish the remainder of the term for chair of the zoning commission. Trustee VanBuren seconded the motion. All in favor

Will Kern asked why the trustees haven't been using the PA system. Trustees said they just didn't think about it and asked if everyone could hear them. Everyone said they could hear fine.

Mr. Kern also asked if the other 2 trustees had any comment on the situation about the alleys in Brownsville. Trustees VanBuren and Hupp said that they let Trustee Watkins handle it.

Jeff Chorpenning reminded the board that there is a member on the zoning commission with an expired term. He also would like an update on the disciplinary action after the incident on Cooperrider Road.

Trustee VanBuren made a motion to renew the term of Yetta Paeltz on the zoning commission. Trustee Watkins seconded the motion All in favor.

Trustee VanBuren made a motion to pay the bills; sign purchase orders and blanket certificates, and the bank statement. Trustee Watkins seconded the motion. Motion Carried. It is lawfully certified that the amount \$14,552.41 is lawfully appropriated to pay the bills by the fiscal officer.


