Barb would like the township to consider taking steps to resize the roads and streets in Brownsville. Some of them have a right of way that is wider than necessary and some buildings are actual built in the right of way. She will find out more information and bring it to the next meeting.

<u>Unfinished Business</u> Trustee Hupp received some information from the county auditor's office about the fire levies. If the township were to do replacement levies instead of renewal levies, the township would receipt approximately \$11,917.00 more per year for the 3 levies once all levies are replaced. This costs roughly \$35 per year based on a \$100,000 home. Trustee Hupp made a motion to have another meeting with the fire departments on March 12th, 2019. Trustee Glaub seconded the motion.

Trustee Hupp received an estimate for building a new cinder building. KNK construction turned in an estimate for \$46,800 for a 30x36 building with 2 bays. He will contact a couple of other companies for estimates.
